

SUPERINTENDENT OF PUBLIC WORKS TOM TILEBEIN TO RETIRE

January 29, 2010 will be the last day of work for Tom Tilebein, Hilton's Superintendent of Public Works; Tom is retiring. For the past 21 years Tom has served as Superintendent and upon his

retirement, will have worked for the Village for 33½ years. The Hilton community will be at a great loss when Tom leaves. Over the years he has proven himself to be dedicated, hard working and a very talented individual. He will be greatly missed.

Tom's career in the Village of Hilton began in 1976, when he was hired by Bob Elliott, Village Administrator, as a laborer, under the Supervision of George Sheffield, Street Superintendent, Jim Ingham, Water Superintendent and Mayor Tom Younker. After a short 4 years with the Village, Tom's talents and work ethic quickly excelled him in his career. In 1980, Jim Ingham was made Village Administrator and Tom was promoted to Assistant Superintendent and



Community Center Manager. His duties entailed overseeing the reconstruction of the Community Center after a fire damaged a portion of the building. He was also charged with the reconfiguration of the building space to prepare for village offices to relocate from Main Street. By 1989 George

Sheffield retired and Tom was promoted to the position of

Superintendent of Public Works.
Jim Ingham retired as Administrator in 2000. The Village eliminated the position of Administrator and

the duties were divided up between Tom and Janet Surridge, then Clerk Treasurer, increasing the responsibilities of both Tom and Janet to what they are today.

Tom has had many accomplishments throughout his career that he can be very proud of. A few of the projects that Tom was responsible for are as follows. From 1989 to 1995 he headed the cleaning and re-lining of the water distribution system within the village; an unseen but

vital project. He was involved with the new construction of many of the subdivisions in the early 1990's. He headed up the major conversion project of the Hojack railway bed to a roadway and designed and supervised the Jennejahn Lodge, Village Park and Salmon Creek Park development projects. He coordinated the house tear-down and post office site preparation for our current post office and was also charged with the recent fire hall demolition. That project

resulted in the recycling of over 99% of the building and site materials. Tom was also responsible for the purchase of the street lighting system from

RG&E. The list of Tom's accomplishments goes on.

Tom has also been active on many committees. He currently represents the County Executive on the Monroe County Recycling Advisory Committee, and throughout his career he has been heavily involved in promoting recycling and has saved the village untold amounts of money by his recycling efforts. He chaired the Monroe County

Storm Water Coalition from 2007-2009 and currently serves as Hilton's representative. Under Tom's leadership the Village was awarded the 2006 NYS Environmental Excellence Award from the DEC. He is also on the Board of Directors for the Upstate NY Municipal Workers Compensation Group. In 2006 and 2008 the Village was awarded the best safety record under Tom's leadership.

In an unusual decision, Tom hired the first female member of the DPW crew, because of her outstanding qualifications.

Since 1976 Tom has lived in the village with his wife Mary, of 35 years. His future plans include golfing, boating and doing things of interest.

When asked about his years working for the Hilton community, this is what Tom had to say.

"First, I'd like to thank every employee that I have had the pleasure of working with, for their dedication and hard work. The residents of this village should be as proud of your accomplishments as I have been. You are truly an exceptional group of individuals that provide more services to one of the larger village populations, with the least number of staff. Village residents certainly get their money's worth, and I thank each one of you for demonstrating a proud work ethic each day."

"Secondly, it's not often that someone from outside the Hilton area is given the opportunity to serve in this position. The motto of the "Little Village with a Big Heart", is true. I was

PROMOTIONS TRANSFORM OFFICE STAFF

The Village Board recently announced the addition of a new position within the Village Office and has promoted three of the office staff employees. The newly added position is that of Village Manager of which Janet Surridge has been promoted. Shari Pearce

has been promoted to Village Clerk and Maryalice Edwards promoted to Village Treasurer.

With the approaching retirement of Tom Tilebein, DPW Superintendent, the Board felt a new position in the office was warranted. As the new Village Manager, Janet is assuming a large portion of Tom's

administrative responsibilities and will combine the remainder of his obligations with those of both Mike Lissow, Code Enforcement Officer, and Mike McHenry, Tom's replacement.

99% OF FIRE HALL BUILDING RECYCLED

Hilton Village Public Works else that could be salvaged was crews along with crews from the Town of Parma Highway Department joined forces to dismantle and tear-down the old fire station on South Avenue. The combined undertaking resulted in a very successful recycling project.

Before the demolition began, professional crews came in to remove any asbestos within the structure. Following, village and town crews united to remove anything of value from the building. Wiring, duct-work, piping, metal trusses, door frames, metal doors, water lines, sewer lines and anything



removed and turned in for scrap to be recycled. During the demolition, the main components of the structure were also separated. The steel was sent to a metal recycling plant. The cinder blocks, brick and concrete slab were crushed up to make stone aggregate for use in future village construction projects. Only a very small portion of the structure was unsalvageable; including the asbestos, drywall, wood, ceiling tiles, roofing and miscellaneous garbage.

RECYCLING - SCALES ON EQUIPMENT HELP CUT DOWN ON WASTE

The Village of Hilton is very fortunate to have employees who are concerned about the environment. Superintendent of Public Works, Tom Tilebein, is one such person. Under Tom's leadership, Hilton became the first village in New York State to install weight measuring scales on their refuse equipment. The purpose of these scales is to measure the amount of waste that is going into landfills. The village subsequently set new

guidelines for residents on how much refuse could be picked up on a given stop. Restrictions were also added to what types of materials that could go into the refuse containers. Brush, leaves, wood chips and grass clippings were eliminated from the solid waste stream. In turn, those items that were eliminated were picked up separately and recycled. This helped to keep village costs down and helped people to cut down on waste.

Landfill sites charge by the ton. By reducing waste tonnage and recycling the materials we can, we help the earth and we help ourselves.

RG&E DROPS "Voice Your Choice"

VILLAGE PROGRAM INVITES NEW CUSTOMERS

In a soon to be announced decision, RG&E will be dropping their "Voice Your Choice" electricity program. The program offered customers the opportunity to choose from a fixed rate or a variable rate plan. The change will take place after January 1, 2010. Reasons for the change are unclear, but following the approval of the Public Service Commission, customers of RG&E will be offered a variable rate plan only. The Village of Hilton's electricity program will be unaffected by the change. The program will continue to offer both fixed and variable rate plans and will remain a stable provider that customers can depend on from month to month.

Customers will enjoy uninterrupted service. Interested persons are invited to inquire by calling the Village office at 392-4144 to sign up.

History of the two providers shows the Village plan provides a savings over the RG&E rates.

VILLAGE WEBSITE OFFERS NEW FEATURES

The Village of Hilton website is continuously being updated and now offers some new features.

WATER BILLING SCHEDULE CHANGE

The Village Clerk would like to announce a change in the water billing schedule. Due to the increasing cost of postage and a heavier work load in the summer months, a new billing schedule has been approved.

Currently, water bills are mailed four times a year. With the new schedule they will be mailed out three times a year. Rates will remain unchanged at \$2.70 per 1,000 gallons and \$.13 per day. Bills will be calculated for four months instead of three and will be mailed the first week in January, May and September.

The office staff is always looking for ways to improve efficiency and reduce costs to tax payers. Any questions, please call the Village office at 392-4144.

STREETLIGHT REPLACEMENT

The office staff would like to clarify how street lighting repairs are handled and why.

To maintain cost efficiency of labor and equipment use, streetlight replacements are done when a minimum of 10 bulbs have been reported out. Wait time for replacements may vary as little as a few days to a more lengthy period of up to 3 months. Fixing just one bulb at a time is too costly and non-productive. Outages must first be listed, then serviced when crews can attend several on one date.

Please be patient and rest assured that repairs will be made in as timely a manner as possible.

PUBLIC WORKS CREW RECOGNIZED FOR EXCELLENCE IN SAFETY

Because of their conscientious efforts to make job safety a priority, DPW employees have been

recognized by the Monroe County Worker's Compensation Program for one of the best safety records in the county. Their outstanding record has helped to save the Village thousands of dollars. 2008 brought the Village a \$30,000.00



refund from the insurance company. In 5 years the Village has received over \$130,000.00 in refunds from lack of claims. Insurance rates have decreased.

WHAT'S NEW IN HILTON

HOVEY STREET TO BECOME



The Village Board and the NYSDOT are considering changing traffic direction on Hovey street from two-way to one-way, northbound only. The roadway will be used as an inlet allowing traffic from the Main Street area into Hovey Square. Outlets will remain on Lake, Railroad and East Avenues. The recommendation to go forward with this change came from the year-long Main Street district traffic study, done in 2008. The Board is open to trying this transformation for a period of time, and will study the results. The change is supposed to significantly improve the safety and efficiency of the intersection at Main and Hovey Streets. The change will take place in the Spring of 2010.

NEW MASTER PLAN FOR HILTON

VILLAGE BOARD SEEKS INTERESTED COMMUNITY PARTICIPANTS

The Village Board is seeking individuals from the Hilton community who are interested in participating on a committee, seeking to update and modernize the master plan of the Village.

Hilton's original master plan was put together in 1977. The 100+ page document, was created to give guidance and direction to board members and help them in setting goals for the future. The document highlights concepts and proposals including such things as improvements,

planning endeavors, zoning guidelines, land use, and a general vision of the future. Such a document is necessary for determining budgetary needs and provides for the possibility of obtaining grant money for future projects.

The Board seeks to revise and update the very detailed and well written document to make it current and incorporate other documents and amendments that have been added since.

Currently the Board has

budgeted \$10,000 toward the revision. A total of \$25,000 may be needed for completion.

The committee will be selected by June 2010 and if budget permits, will proceed in the later part of next year.

Saturday, July 25, 2009 will be remembered as the day that Hilton was hit by a tornado.

The following information was gathered from the National Weather Service website, and used with permission courtesy of NOAA/NWS.

During the late afternoon hours on July 25, 2009, severe weather developed over Western NY between Buffalo and Rochester. The first storm moved across northern Erie County with numerous funnel cloud sightings and hail to 1 inch diameter. This storm weakened as it moved to the northeast

while a second storm formed rapidly to its south, and eventually produced two tornadoes across Western NY. The first occurred at 4:50pm EDT, touching down in the town of Darien, just southwest of the Village of Corfu in Western Genesee County. The second tornado occurred at 5:55pm EDT touching down in the Village of Hilton in Western Monroe County. The damage was less extensive than the first tornado, with primarily tree damage and broken outdoor furniture. One home sustained minor structural damage. The tornado was on the ground for about 10 minutes, had a 1.5 mile long path, 30 yard width and a rating of Ef0, with peak winds estimated at 75 mph.

The storm had unfortunate timing for the Hilton Fire Department. The annual

carnival was in full swing when the National Weather Service broadcast warnings of severe weather. The severe weather broadcasts quickly changed to an imminent tornado warning. Thanks to the quick thinking and fast action of fire department personnel, the carnival was quickly shut down and the grounds were evacuated. People were moved into the near-by exempt club, located on the hill just south of the carnival grounds, where they remained until the storm safely passed. This was the first time that the carnival had to be cancelled. The fireman's field was flooded, resulting in a great deal of cleanup work. Fortunately there were no injuries from the storm.

The tornado was the first in Monroe County since September 1981.

Before 1900, there was no formal Village Historian; there were however, people who were interested in what went on in times gone by. Mary Archer Stevens might be considered the first person to collect villagerelated history. Another was William V. Newcomb, who collected early photos of the village and labeled them. Following was Elizabeth V. Keller, the first official Village Historian. Then came Leith C. Wright. Although she was never historian of the Village, Shirley Cox Husted, sister of Leith and Town Historian, contributed much to the Hilton archives. Following Leith was Mary

Townsend, and currently, me.
