Privacy Notice

Federal regulations require us to inform you of what we do with your private information. It is the policy of the Village of Hilton ("**Village**") to maintain information about our customers (current and former) obtained in the course of our business relationship for our internal use and to share that information with others only as permitted by law and in accordance with any expressed directions of our customers.

Confidentiality and Security

We restrict access to nonpublic personal information about you to our employees who need to know that information to provide products or services to you in an efficient manner.
